PROJECT DESCIPTION

1. Introduction

- 1. The Ministry of Health (MoH) has high responsible implementing on integration approach of health service provision include prevention service, health education, diagnosis, treatment and maintain and rehabilitation via providing quality, safety and efficiency service. Health service system basically focused on service provision or public health intervention which relating on resident health and impact of society on health as well. Those service provisions are aimed to reduce disease and death of mother, baby and children, and reduce the infectious and non-infectious diseases and public health issue. MoH has planned on Upgrading Quality of Health Service of Kampong Cham Provincial Hospital in the purpose of serving a better health care service for general population in the region.
- 2. The proposed project for Upgrading Quality of Health Service of Kampong Cham Provincial Hospital is consist of removing of existing building and construct new building. Additionally, new facilities are planned to be constructed including advance medical service block, general medical service block, mortuary and septic tank. The project has several concepts to be improved including provide the best quality medical service, tertiary health with accurate diagnosis and more effective and efficiency treatment for local people, and new medical technologies in the regions. The improvement of advanced medical services is to strengthen healthcare by establishment of training system on the utilizing of advanced technologies. This strengthening of health sector has been obtained the financial loan from Japan International Cooperation Agency (JICA) accordance to requesting of the Cambodian Government.

2. Kampong Cham Provincial Hospital

3. Kampong Cham Provincial Hospital was built in 1930 during French colonial period. There are 6 building for first construction and after that some old building was demolished and constructed the new building instead. Up to 2020, some old buildings have not been renovated yet which it is still operated






as the consultation building. Currently, the Ministry of Health (MoH) aimed to promote the quality of health service of Kampong Cham Provincial Hospital. Thus, Japan International Cooperation Agency (JICA) has supported as financial loan accordance to requesting of the Cambodian Government to strengthen and improve the health sector by demolishing the existing facilities and construct new building.

The proposed project for Upgrading Quality of Health Service of Kampong Cham Provincial Hospital of Ministry of Health (MoH) is located at Village 7th, Sangkat Kampong Cham, Krong Kampong Cham, Kampong Cham Province which land size is approximately 38,197.34 m². It is located in front of Kampong Cham city hall, and north border close to Preah Bat Ketomealea Street, earth border close to Preah Bat Soriya Varoman II street, west border close Kampong Cham provincial health secondary school and south border close to Preah Sangkhareach Tieng Street.

5. The proposed project for Upgrading Quality of Health Service of Kampong Cham Provincial Hospital is consist of removing of existing building and construct new building. The existing building which will be demolished including emergency and general medicine, meeting room, septic tank, operation theater and ambulance station. The demolishing of those building is aimed to improve the facilities in the hospital by constructing the advanced medical services building, general medical services building, mortuary, and septic tank. The facilities and upgrading area in the hospital show in following figure.




Figure 1: The facilities and the upgrading area in the hospital
