



SUMMARY OF 1ST PUBLIC STAKEHOLDER CONSULTATION MEETING
ON
THE PROJECT FOR UPGRADING QUALITY OF HEALTH SERVICE OF KAMPONG
CHAM PROVINCIAL HOSPITAL

1. Introduction

1. The Ministry of Health (MoH) has high responsible implementing on integration approach of health service provision include prevention service, health education, diagnosis, treatment and maintain and rehabilitation via providing quality, safety and efficiency service. Ministry of Health (MoH) has planned on Upgrading Quality of Health Service of Kampong Cham Provincial Hospital in the purpose of serving a better health care service for general population in the region.

2. The proposed project for Upgrading Quality of Health Service of Kampong Cham Provincial Hospital is consist of removing of existing building, and construct new building. Current internal medical ICU and the former surgery block will be replaced by advanced medical services block and general medical services block, respectively. Moreover, the mortuary building is also supposed to be constructed for this proposed project. The improvement of advanced medical services is to strengthen healthcare by establishment of training system on the utilizing of advanced technologies.

2. Objective

3. The project for Upgrading Quality of Health Service of Kampong Cham Provincial Hospital aimed to:
- Improve on health sector in Cambodia
 - Improve the quality of health service and public health intervention
 - Reduce disease and death of mother, baby and children
 - Reduce the infectious and non-infectious diseases and public health issues
 - Career opportunity and income provision for local people

3. Project Description

- Project owner: Ministry of Health (MoH)
- Financial fund: Technical and Financial Support - Japan International Co-Operation Agency (JICA)
- Project Location: Village 7th, Sangkat Kampong Cham, Krong Kampong Cham, Kampong Cham Province
- Construction Area: 30,000 m²



- Plan for Starting the Construction: 2027
- Plan for Finishing the Construction: 2030
- Plan for Operation: 2031
- Demolishing building plan: Internal medical ICU block and the former surgery block
- New construction building plan: Advanced medical service block, general medical services block and mortuary building

4. Result of 1st Public Stakeholder Consultation Meeting

4. The 1st Public Stakeholder Consultation was held on 03rd May, 2023 at 9:00 am - 11:00 am, Sangkat Kampong Cham Hall. There were 34 participants who attended the meeting hall. The above project was supported 96% of participants and other 4% of participant needed more time to consider. People supported the project due to the project will provide the benefits for local people such as:

- Advance technology for treatment/medical service
- Best service for local people and no need to find the treatment service at abroad
- Improve the facilities and quality service of Kampong Cham hospital

5. Nevertheless, the local authority and people also have the concerns on some activities during project construction and operational phase such as:

- Noise/vibration disturbance
- Transportation of construction materials will able to produce dust and fall the materials on the ground
- Worker activities will able use the drug
- The smoke from medical incinerator is spreading to the people nearby the Kampong Cham hospital

6. Meanwhile, they suggested to the project as following:

- Limit the speed of driving, proper pack and cover the construction material for the activities of transportation
- Re-check on medical waste incinerator to avoid the smell and smoke spreading to the environment and people living near the hospital; especially people living in Village Ti Prampir
- Be well manage and educate the worker to avoid using drug during construction phase.

7. Thus, it can be assumed that there are not many concerns from the relevant stakeholders on the proposed project. The proposed project was strongly supported by local authority and people.

5. Response to Participants

8. To response to participant's concerns



- In Kampong Cham hospital, there is drug substance test service without charging and patient is able to be treated at their own home
- The old chimney of medical waste incinerator was longer but it was broken. That is why it is changed to the new one which is shorter than the old one
- The chimney will be re-upgraded to be longer and select the suitable time for burning
- Kampong Cham hospital is studying more on medical waste burning to be modern and better
- If there is any possible impact such as noise/vibration, transportation issue during project construction and operational phase, the project will find the solution for effected person by the project
